आपके आवेदन पत्र दिनांक. 16-06-2025 और उसके क्रम में आपसे किये गये पत्राचार एवं विद्यालय के किये गए निरीक्षण एवं जिला स्तरीय त्रिसदस्यीय समिति के बैठक दिनांक : 13-02-2026 में किये गए निर्णय के आलोक में आपके विद्यालय Kids Camp International School, Kids Camp International School, Narauli Sen, Binda, Muzaffarpur, Narauli Sen, 843119 को कक्षा 1 से 8 तक संचालन हेतु तीन वर्षों 13-02-2026 से 13-2-2029 अवधि के लिए औषबंधिक प्रसूचीकृति प्रदान की जाती है।

प्रदत्त प्रसूचीकृति निम्न शर्तों के अनुपालन के अधीन होगी।

1. प्रसूचीकृति किसी भी परिस्थिति में कक्षा 8 तक की सीमा के बाहर मान्य नहीं होगी।
2. विद्यालय बच्चों की मुफ्त एवं अनिवार्य शिक्षा अधिनियम, 2009 तथा बिहार राज्य मुफ्त एवं अनिवार्य शिक्षा नियमावली 2011 का अनुपालन आवश्यक रूप से सुनिश्चित करेंगे।
3. विद्यालय अपनी कक्षा 1 में बच्चों के नामांकन की कुल क्षमता का 25 प्रतिशत बच्चों का नामांकन अपने पड़ोस के कमजोर वर्ग एवं अलाभकारी समूह के बच्चों का करेगा तथा उन्हें मुफ्त एवं अनिवार्य प्रारंभिक शिक्षा उसकी पूर्णता तक प्रदान करेगा, परन्तु यह कि यदि विद्यालय में पूर्व प्राथमिक कक्षाओं का संचालन हो रहा है, तो इस मानक का अनुपालन पूर्व प्राथमिक कक्षा के लिए भी किया जाएगा।
4. कठिका 3 में उद्धृत बच्चों के मामले में विद्यालय को बच्चों की मुफ्त एवं अनिवार्य शिक्षा अधिनियम की धारा 12 की उपधारा 2 के आलोक में निर्धारित राशि की प्रतिपूर्ति की जाएगी। प्रतिपूर्ति की जानेवाली राशि की प्राप्ति के लिए विद्यालय अलग से बैंक खाता का संधारण करेगा।
5. सोसाईटी / विद्यालय के द्वारा किसी प्रकार का कैपिटेशन फीस नहीं प्राप्त किया जाएगा तथा किसी भी बच्चा उसके माता-पिता या अभिभावक का स्क्रीनिंग टेस्ट नहीं किया जाएगा।
6. विद्यालय किसी बच्चे के नामांकन से उसके उन्नत प्रमाण पत्र के अनुपलब्धता नामांकन की विस्तारित अवधि के बाद तथा धर्म, जाति, जन्म स्थान आदि कारणों या इसमें से किसी एक कारण के आधार पर इंकार नहीं कर सकेगा।
7. विद्यालय के द्वारा निम्न कार्य सुनिश्चित किए जाएंगे. :

- (i) किसी भी नामांकित बच्चे को किसी भी कक्षा में रोककर नहीं रखा जाएगा और न ही किसी नामांकित बच्चा को प्रारंभिक शिक्षा पूरी होने तक विद्यालय से निष्कासित किया जाएगा।
- (ii) किसी भी बच्चे को किसी प्रकार का शारीरिक दंड नहीं दिया जाएगा तथा मानसिक रूप से प्रताड़ित नहीं किया जाएगा।
- (iii) किसी भी बच्चे को प्रारंभिक शिक्षा पूरी करने के लिए किसी भी प्रकार के बोर्ड परीक्षा पास करने की आवश्यकता नहीं होगी।
- (iv) प्रारंभिक शिक्षा पूरी करने वाला प्रत्येक बच्चा को नियम 22 के आलोक में प्रमाण पत्र प्रदान किया जाएगा।
- (v) अधिनियम के प्रावधानों के आलोक में दिव्यांग बच्चों का समावेशन किया जाएगा।
- (vi) शिक्षकों का नियोजन अधिनियम की धारा 23 की उपधारा 1 में उनके लिए निर्धारित न्यूनतम योग्यता के अनुरूप किया जाएगा।
- (vii) शिक्षक अधिनियम की धारा 24 की उपधारा 1 में प्रावधानित शिक्षकों के दायित्व का निर्वहन करेंगे।
- (viii) शिक्षक निजी स्तर पर किसी भी प्रकार की शिक्षण गतिविधि में संलग्न नहीं होंगे।

8. विद्यालय केंद्र सरकार अथवा राज्य सरकार द्वारा निर्धारित पाठ्यक्रम एवं पाठ्यचर्या का अनुसरण करेगा।

9. विद्यालय अधिनियम की धारा 23 के आलोक में उपलब्ध सुविधाओं के आनुपातिक रूप से छात्रों का नामांकन करेगा।

WHEREAS the settlers declared a Trust and the Trust deed was registered at District Registry Office, Muzaffarpur on dated 15th Day of December 1999 as Document No. 126 / IV - 1999 Book No.-3, Page no. 107-126.

AND WHEREAS the trustees resolved to apply for grant of Registration U/s 12AA of the Income Tax Act but in the course of close scrutiny of the Trust deed it was pointed out that there is no clause in the Trust deed regarding disposal of trust property on dissolution of the Trust. Creation and Liquidation both are natural process. It can not be ruled out that sometimes in future the trust will dissolve. Once the trust is a public charitable trust its property on dissolution can only be appropriated by some other charitable organization and it can not be appropriated by any person or organization for their personal benefits. However in absence of a specific clause in the Trust deed there may be disputes for disposal of property. Once the issue has been raised specific mention for disposal of Trust property on dissolution is required to clarify intention of the settler. Accordingly matters relating to appropriation of Trust property on dissolution lacking in the Trust Deed requires supplementation. It was thought expedient to insert the following clauses in the trust deed by this supplementary Trust deed to avoid any unintended situation at the time of dissolution. In case the clause hereby supplemented derives any contradictory meaning and are different from the original trust deed dated 15.12.1999 the provisions of this supplementary Trust deed shall prevail.

INSERTION OF A CLAUSE NO. 7 (za) AT PAGE - 8 AFTER CLAUSE .7 (z)."

At the end of the Clauses under the heading "POWER OF TRUSTEES" following new sub-clause No. (za) after sub-Clause (z) of Clause - 7 be inserted :

"Dissolution of Trust : The trust may be dissolved by 3/4th. majority of the total strength at a special meeting convened for the purpose. If upon the dissolution of the trust there remains after satisfaction of all its debts and liabilities any property, whatsoever, the same shall not be paid to or distributed directly or indirectly to trustees or their relatives but shall be given to or transferred to some other society or fund or trust or Government to be determined by 3/4th majority. In the event of any dispute arising among the trustees the adjustment of its affairs shall be referred to the Principal Court of Original Civil Court Jurisdiction of the district in which the chief building of the trust is situated, and the court shall make such order in the manner as it shall deem requisite".

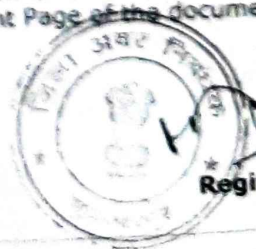
